GENERAL INSTRUCTIONS

Delicia® SLUGGOFF® Lentils has a stomach and contact action in slugs and snails which induces heavy secretion of mucous. Slugs and snails will die from dehydration in a reasonably short time. Delicia® SLUGGOFF® Lentils are particularly active against molluscs. The addition of a bittering agent has made Delicia® SLUGGOFF® Lentils distasteful to mammals and birds. When applied according to the directions for use, non-target organisms will not be affected. Best results are achieved by application after rain, watering or during damp and humid weather when snails and slugs are most actively seeking food, though when rain is not imminent.

Scatter Delicia® SLUGGOFF® Lentils evenly using an appropriate applicator by ground or air, or direct drill with seed for slug control. Ensure spilt Delicia® SLUGGOFF® Lentils are cleaned up.
